Tracking the trends and advising on having an impact

Things began to change dramatically for California schools with the 1978 passage of California Proposition 13, which shifted the 100-year-old system of local control over how to spend funds for schools and how to educate and evaluate students to state policymakers. In other words, affecting education policy shifted from the local school board to Sacramento. One of our Government Affairs and Public Policy team members has more than 30 years of post-Prop. 13 leadership in shaping policies for California educators. We do not advocate directly with legislators, but we closely track legislative trends, aided by our long experience and deep connections within the legislative and policymaking community. We are California's leading resource on educational legislation and policy and regularly inform clients on how to ensure their voice is heard regarding legislation.

F3's broad network of resources

F3s has an extensive network of resources developed over many years that help keep our team informed. We are in the field attending meetings and doing the research. Among our resources are the California Occupational Safety and Health Administration, the State Board of Education, the California Department of Public Health, the Governor's office, statewide education associations, the U.S. Department of Education, and other statewide and federal agencies. We familiarize ourselves with the newly elected state legislators and committee chairs and learn about their views on education issues. We look at the legislative intent when bills are introduced and their rationale, which is not always evident in the bill's language, and advise clients accordingly.

Advising education associations

In addition to keeping our school and college clients updated on what's around the corner, we also work closely with education associations such as the following, which rely on F3 to assist with the review of draft legislation, including:

- California School Boards Association (CSBA) /California Council of School Attorneys (CCSA) (members provides leadership in legislative, political, judicial, community, and media accuracy)



- California County Superintendents (CCA) (county superintendents advocate for high-quality education in California)

We recently worked with ACSA and CSBA to create an annual national advocacy trip to Washington, bringing speakers such as the heads of agencies, pollsters, board members and superintendents, and others to inform Congress of California's priorities in education policy.
